Booking Rules

1. Winter rates and periods shall be determined by the Board each year and printed on the Booking Application Form.
2. Winter booking applications from Members, who must be financial, shall be accepted from 1 March each year. The Booking Officer shall strictly allocate beds in order of receipt of bookings. Unless otherwise advised by the Board bookings from Member's friends will be accepted from 1 April.
3. The number of persons per night is limited to 20. In the event that there are more than 20 applications (excluding children under 5, by the terms of our lease) for a particular period, all those applications will be submitted to the Board, who will conduct a ballot.
4. Bookings are made on a per night basis with a minimum of two nights per booking. Arrival time not before 2 pm, rooms to be vacated by 11am on day of departure. All meals are supplied.
5. Single night bookings are permitted (incl. weekends) if booked within 7 days of day requested, subject to availability.
6. Bookings (other than 1 night) cannot start or finish on a Saturday.
7. All applications shall be made to the Booking Officer on the approved form. The FULL AMOUNT must be paid on all bookings up to and including \$200. Bookings over \$200, 50% must be sent with the booking form.
8. The balance of any booking must be paid 1 month prior to 1st booked day.
9. Should cancellations occur: a cancellation fee of 10% of total accommodation value will be charged if cancellation is received 4 weeks prior to arrival date. Between 4 weeks and 2 weeks prior to arrival date a 50% of total accommodation value will be charged. If the booking is cancelled less than 2 weeks prior to arrival date, the total value of the accommodation will be forfeited unless the beds can be filled.
10. Minimum age for accommodation at Smiggins Lodge is four (4) years.
11. Children will not be granted accommodation unless accompanied by a parent or guardian.
12. Phone inquires may be made to the Booking Officer as per the booking form regarding available dates, but a phone booking must be confirmed within seven (7) days, in writing, enclosing the necessary deposit or the phone booking will be cancelled.
13. A receipt for any money received, with advice as to whether the application has been successful will be mailed to the applicant.
14. Residents at the Lodge desirous of extending their stay, should a vacancy occur, must contact the Booking Officer, and if successful, inform Lodge managers', and pay them the applicable amount.
15. Lodge residents shall at all times occupy the room allocated by the Booking Officer unless alternate arrangements can be made through the Lodge managers'.
16. The Booking Officer, whilst bound by these rules, has a discretionary power to decide any borderline issue and shall report to the Board when such action has taken place.
